#### Germaine Williams- 231 Sherman Street, Passaic, NJ

- ➤ Ms. Williams thanked the Board for addressing all the questions and concerns that some of the Residents had regarding the tutorial program. Ms. Williams also thanked the Board of Commissioners for offering a tour of the program at the Boys and Girls Club.
- Ms. Williams asked if the Board would kindly consider the Satellite Sites that the Boys and Girls Club offered a few years back at either Chestnut or Vreeland.

#### Mr. Jaroslaw Jackiw – 266 Lafayette Avenue, Passaic, NJ

Mr. Jackiw asked the Chairperson of the HACP Board of Commissioners to please confirm the following: Currently the HACP Board of Commissioners of 2016 consists of Chairman employed by the City of Passaic, Three Commissioners Employed by the BOE, One Commissioner appointed by the Governor of NJ, and two Commissioners appointed by the City Council and or City Administration. How many tenant residents serve on the Board of Commissioners?

➤ The Executive Director responded: One.

Now that the NJ State Police approved the purchase of body cameras for its officers, to be founded by Passaic County Sheriff's Office, will the Executive Director/ Board of Commissioners approve the use of

body cameras within all HACP properties by its security personnel including the PPD in 2016?

Who selects the members to the Resident Council?

➤ The Executive Director Responded: The residents elect the Resident Council members

Can the Executive Director advise the Tenant Residents/ Public as to the status of all renovation projects that have been completed at all senior housing properties of 1030 units as of March 31, 2016.

➤ The Executive Director stated that two (2) mock apartments have been completed and that the General Contractor should complete 80 units by the end of the calendar year.

The contract for the current Executive Director expires on June 30, 2016. Will the Board of Commissioners consider going in a new direction when selection a New Executive Director? If not, why not?

Terrence Corriston responded: Even if the Contract does expire for the Executive Director, the Director does not leave.
