- 1.) Brianna Combs 203 Sixth St. Apt. 3D: Lately there has been an enormous number a vehicles parking in the lots without stickers. When you contact the police department they either don't show or when they do show, they flash their flashlights in the window and go about their business. I haven't seen them write any tickets nor have the vehicles been towed. Also, the drug transactions behind buildings 200 and 201 have gotten out of hand. There's traffic in and out at all times. Nothing is being done. When I leave for work early in the morning, I'm scared to walk out of my building because of the crackheads lurking there. On top of that, when I come home in the evening there is no parking because of these vehicles parking there with no stickers. Something needs to be done as soon as possible.
