Evelyn T. Robinson – 222 Sixth St. Apt. 2D: I'd like to thank the Housing Authority for their support on bringing back 'Family and Friends Day'. I'd also like to thank the City for their extraordinary support.

We really need some assistance. We're not receiving what we should have. We're still waiting to see what's going to happen with the playground. It needs to be renovated, or taken away. It is a liability. I really don't want a child to get hurt. Bolts and nails are hanging out. The door situation needs to be dealt with. My next step is to gather my reports and go to Newark because we are not getting any response or support on the local level. We are not being kept abreast of what's happening. Where is the Resident Services Committee? We're trying to do things for our

youth. What's happening to assist us in that? We're doing the right thing; support us in our day-to-day.

Ruby Straight – 14-34 E. Monroe St. Apt. 6B: We're supposed to have a garden here, but there is nothing out there but weeds. We could have done something better with that money. We need a fan in the laundry room. Nobody cares about us. We always complain. We call the work order line and have to leave a message.

- Commissioner Juszcyk: To answer one of your questions, I had worked on the grant for the Community Gardens. That money was coming from the County and it could not have been used for anything other than a garden. I understand there's a lot of weeds and possibly part of the problem is the manager for this facility is not on board right now.
