REMARKS BY CITIZENS

Therefore, please be advised that the Housing Authority of the City of Passaic will not entertain any comments from persons who communicate obscene material, make statements which are considered bias intimidation in which a person intends to intimidate any individual or group because of race, color, religion, gender, handicap, sexual orientation or ethnicity or makes comments intending to harass or speak in any offensive language. The person who makes these statements will relinquish their allotted five minutes for public discussion. Any person who persists in speaking out of turn, or interrupts the peace and order of the meeting will be escorted off the premises.

Germaine Gibson-Williams, 231 Sherman Street, Passaic, NJ

Ms. Gibson-Williams: First and foremost I would like to congratulate the Chairperson and Commissioner Rodriguez for their most recent win for the Board of Education.

- Ms. Gibson-Williams urged the Board to take into consideration everything the Interim Executive Director has given to the Housing Authority over the years. She also remarked "If I am not mistaken she is the most seasoned employee at the Authority".
- ➤ Ms. Gibson-William reported that she has been in communication with the Director of Resident Services Glenny Candelaria and her staff about holding a "Grocery Bingo" on Wednesday, June 6th at the Tutorial Center 45 Aspen Place. She also invited the commissioners to attend some of the activities planned for the summer.

Rene Griggs, 23 Aspen Place, Apt. 6C, Passaic, NJ

- > Reported several complaints about the receptionist.
- Residents formed a private group to organize activities are to support the residents and the kids. It is important to get involved in resident services. She inquired as to what activities are being done other than the Tutorial/Summer Program. She stated that if she does not do activities with the community it is not going to be done. She was told that there was a policy for the use of the Summer/Tutorial Program Center. She has never seen any policy pertaining to the use of the center. She would like to know the procedure. There are outsiders coming to do other activities at Speer.
- > Expressed security concerns There is a need for security services. She stated that there are people on the Trespass List assaulting minor children while going home to their

- residence. Do your mission to provide safe, affordable, decent housing. When you have children assaulted while going home you have not done due diligence. It is not being done for the safety of the residents. She stated that residents at Speer have gathered and consulted lawyers to bring back action.
- If you had the best interest of the residents you would make sure that every department under you function at the capacity it should have. When you say invocation that

Kirt Robinson, 45 Aspen Place, Apt. 1D, Passaic, NJ

- Lived at 14-34 E. Monroe and had to move because he was over the income while he was working under the RAD Program. He had to move, but was told he could come back when he was no longer over the income. He was offered a studio apartment and he told them he could not accommodate all his things in a studio. As a result, he was advised he had to wait three years to move back to the senior site.
- ➤ Chairperson Van Rensalier asked Director Mitchell to address Mr. Robinson. Director Mitchell asked Mr. Robinson to meet with her tomorrow morning at 9:00 a.m. to address his concerns rather than in public.

Thomas Curtis, 14-34 East Monroe, Apt. 7A, Passaic, NJ

- Mr. Curtis stated that he was promised a floor while they were remodeling tiles coming off the floor and nothing has happened. In addition, there is rain coming through the door. Awnings were supposed to be installed and it did not happen.
- ➤ Chairperson Van Rensalier asked Ms. Arroyo to address the Board. Ms. Arroyo reported that damage to floor is circumstantial from the rain coming into the unit. She added that there are other units having the same issues as a result of the awnings not being replaced. She reported that she began the process of the procurement due to the serious nature of this matter.
- > Chairperson Van Rensalier asked Director Mitchell to address the Board regarding this situation. Director Mitchell stated she was made aware of the problem from Mr. Curtis, but will revisit that tomorrow morning.
- ➤ Chairperson Van Rensalier asked Mr. Curtis to contact Director Mitchell and she will update him as to what steps she is going to take to make sure that the situation in his apartment is corrected. He also asked Mr. Curtis to come back next month to let the Board know that it was taken care of.

Ethel Dollar, 14-34 East Monroe Street, Apt. 5G, Passaic, NJ

- Ms. Dollar reported she suffered two strokes and have someone living above her playing ball all the time.
- > She complained to the property manager. Her bathroom shower handle bar was moved and a soap bar was installed. It is very difficult for her to get in and out of the tub.
- ➤ Chairperson Van Rensalier: He asked that the manager report to the Board at the next meeting.

Patricia Jackson, 14-34 East Monroe Street, Apt. 2D, Passaic, NJ

➤ Having a problem with the sink at night. It is always bubbling. Chairperson Van Rensalier asked if she reported it to the manager and Ms. Jackson said she did.
