1.) Angelica Grullon – 220 Sixth St. Apt. 3D: My apartment entry door has not been replaced. It has been almost 3 months. I have been told several times that the door has been ordered. At this point I have found my complaints to be useless because nothing gets done. Management was quick to give me a fine, but not quick enough to fix things. Let's talk about the entrance door to the buildings. I'm pretty sure if they monitor the building, they can see who keeps damaging both the entrance doors. I don't know what it is with 220 Sixth Street; that building always gets ignored. The doorbells work to buzz people in but you still have to yell out the window to find out who it is because the intercom is not working.

Executive Director Mitchell: Just so you know, the manager is aware and she is addressing the tenant's apartment door.

Chairman Rodriguez: When was this submitted?

Executive Director Mitchell: This was submitted the end of June. It was actually submitted, in error, for my agency plan meeting. I reached out to the tenant and let her know that was not the appropriate meeting for that.

Chairman Rodriguez: Since June, it has been addressed? Not just the concern with her own apartment, but the concern with the building? Can we follow up and send something to the commissioners? We want to make sure these issues are being addressed.
