REMARKS BY CITIZENS

The following was read: In accordance with the Open Public Meetings Act (N.J.S.A. 10:4-1 et seq.) The Housing Authority of the City of Passaic opens every public meeting for comments of the public. Each person choosing to speak at the meetings will be limited to five minutes, to speak on any subject, on or off the agenda. All speakers must state their name and address for the record. However, in accordance with N.J.S.A. 10:4-12 "nothing in this Act shall be construed to limit the discretion of a public body to permit, prohibit or regulate the active participation at any meeting"

Therefore, please be advised that the Housing Authority of the City of Passaic will not entertain any comments from persons who communicate obscene material, make statements which are considered bias intimidation in which a person intends to intimidate any individual or group because of race, color, religion, gender, handicap, sexual orientation or ethnicity or makes comments intending to harass or speak in any offensive language. The person who makes these statements will relinquish their allotted five minutes for public discussion. Any person who persists in speaking out of turn, or interrupts the peace and order of the meeting will be escorted off the premises.

Renee Griggs, 23 Aspen Pl. Apt. 6C: Happy holidays to everyone. We definitely miss Mr. Pacheco; and building 33 has not been cleaned in the manner it had been since Roosevelt Johnson. Wesley has been a person you would want to have living in your community. He is caring about the children and is there to lend a helping hand whenever he can.

Paulette Gathers, 202 Sixth St. Apt. 3C: There is an issue with building 200 and 203. There are people in the backyards using drugs. It has been reported to the Security Investigator. Can something be done about that?

Evelyn T. Robinson, 222 Sixth St. Apt. 2D: As I was decorating for Christmas and there was a strong marijuana smell inside the building. Too many residents are ruining the quality of life. I am asking that a formal meeting take place with the Security Investigator and the Executive Board.

- Chairman Van Rensalier: Before you leave, please meet with Security Investigator to set up a meeting with residents and your officers so that the issue can be resolved. The

Security Investigator can also coordinate with the City to bring the police officers from the City and the narcotics unit into the situation as well.

- Ms. Robinson: I would hope that the new contract with the City requires that police officers get out of their cars and walk the streets and buildings.
- Chairman Van Rensalier: Come back next month and give us any updates on what is going on.

Commissioner Rodriguez: Ms. Robinson, thank you for your report. I enjoyed reading it. The Security Investigator's job is to investigate and alert the police. But as citizens we also need to do what our part is. We must call the police every time there is an incident and continue to call until they have no choice but to patrol the area. My advice is to continue to call until something is done.

- Chairman Van Rensalier: Document every time you call, whether it be a response or non-response.
- Commissioner Rodriguez: That information can be given to the Security Investigator and he can report it to the Chief of Police.

A motion was made by Chairman Van Rensalier, seconded by Commissioner LaBoy to close the *Remarks by Citizens* portion of the meeting.

2018-74 RESOLUTION OF THE HOUSING AUTHORITY OF THE CITY OF PASSAIC AWARDING A CONTRACT FOR ELEVATOR MAINTENANCE AND REPAIR AT ALFRED SPEER VILLAGE AND THE HECHT AND MURPHY APARTMENTS FOR A TWO (2) YEAR PERIOD IN THE AMOUNT OF ONE HUNDRED SEVENTY-SIX THOUSAND FOUR HUNDRED DOLLARS AND NO CENTS (\$176,400.00).

- Commissioner Rodriguez: If Executive Director Mitchell can go over on how we came up to that number, as it seems a little high.

- Robert Sforza: Six contractors picked up specifications, but only one bid.

- Commissioner Rodriguez: What exactly does the contract entail? Was there a bid process?
- Robert Sforza: There were five or six specifications given out. There was only one bid. The price has been the same for the past five or six years. It entails cutting grass, mulch, leaf raking, weeding, and putting down fertilizer. They have a monthly schedule.
- Terrence Corriston: In the future, include the name of the contractor being awarded in the resolution so it can be on the record.
- Chairman Van Rensalier: What is the process for advertising?
- Robert Sforza: We advertise in the Herald News, the Record and on our website.
- Chairman Van Rensalier: In the future, we need to advertise in Latino newspapers and reach out to local contractor.

2018-82 RESOLUTION ADOPTING A MEMORANDUM OF UNDERSTANDING BETWEEN THE HOUSING AUTHORITY OF THE CITY OF PASSAIC AND THE CITY OF PASSAIC TO PROVIDE SPACE FOR ENVIRONMENTAL RESOURCE CENTER IN THE CITY OF PASSAIC, NEW JERSEY.

A motion was made by Commissioner Rodriguez, seconded by Commissioner Fernandez, to approve Resolution 2018-82.

- Commissioner Juszcyk: On the MOU, item 4 states the City shall provide all security and basic maintenance. Would the security be in form of Passaic Police Officers and is that separate from police services in the contract with the Housing Authority?
- Chairman Van Rensalier: Yes, that would be my understanding.
- Commissioner Juszcyk: Would basic maintenance include pest control?
- Chairman Van Rensalier: I think it would only be the cleaning of the interior. Cleaning up after the participants.
- Commissioner Juszcyk: I think it would be beneficial to us if it included any needed pest control after the use.
- Chairman Van Rensalier: I ask the Executive Director to clarify with the City and amend to MOU if necessary.
- It also mentions NJ code blue weather regulations and my also include code red. What are the parameters for lower and upper range for this to be utilized? Would precipitation also be a factor?
- Chairman Van Rensalier: I think it would be helpful if you didn't think of it as "code red" or "code blue". Think of it in terms of extreme weather conditions. When it comes to extreme weather conditions, that call is mandated by state.
- Commissioner Juszcyk: Are there any other cities with similar MOUs?
- Commissioner Rodriguez: To me it doesn't matter if other Housing Authorities have it. To me it's the right thing to do.
- If there are any fliers going out, can the Housing Authority also get credit for participating in this program?
- Commissioner Rodriguez: This is just temporary. Once the Dignity House is up and running the city will no longer utilize the space.
- Chairman Van Rensalier: It will not just be a space where people can cool off or keep warm. There will be other services provided.
