#### **OLD BUSINESS**

- > Commissioner Navarro stated that the mission statement could be reviewed at the next Commissioner Retreat.
- > Commissioner LaBoy asked for a copy of the Missioner Statement.
- Yetla Martinez read the Mission aloud to the Board of Commissioners.
