REMARKS BY CITIZENS

The following was read: In accordance with the Open Public Meetings Act (N.J.S.A. 10:4-1 et seq.) The Housing Authority of the City of Passaic opens every public meeting for comments from the public. Each person choosing to speak at the meetings will be limited to five minutes, to speak on any subject, on or off the agenda. All speakers must state their name and address for the record. However, in accordance with N.J.S.A. 10:4-12 "nothing in this Act shall be construed to limit the discretion of a public body to permit, prohibit or regulate the active participation at any meeting"

Therefore, please be advised that the Housing Authority of the City of Passaic will not entertain any comments from persons who communicate obscene material, make statements which are considered bias intimidation in which a person intends to intimidate any individual or group because of race, color, religion, gender, handicap, sexual orientation or ethnicity or makes comments intending to harass or speak in any offensive language. The person who makes these statements will relinquish their allotted five minutes for public discussion. Any person who persists in speaking out of turn, or interrupts the peace and order of the meeting will be escorted off the premises.

Due to Covid19, members of the public who had questions or comments were asked to submit them in writing to the administrative office located at 52 Aspen Place or send them via email to the Executive Director at boardmeeting@passaichousing.org before the close of business day at 4:00 pm Tuesday, February 16, 2021.

Director Mitchell: We have two remarks from citizens.

- **1.) Secundino Toribio 299 Gregory Ave. Apt. 2C:** Can the post office put a mailbox in the front of the building? Can the Housing Authority put snow removal equipment that can be used by the residents in the hallway so that they can clean and shovel out their cars?
- Executive Director Mitchell: Both of these questions were answered by the Property Manager and it will get a follow up response to acknowledge that the Board was made aware of their request.
- Chairman Rodriguez: That does sound like a good idea with the mailbox in front of the building. Maybe we can get the post office to do something, not sure what their process is to do

that. As far as the snow removal equipment, that may be a liability. Besides, we have maintenance staff that takes care of the grounds.

- 2.) Angie Grullon 220 Sixth St. Apt. 3D: The lack of common sense during this recent snowfall that we had is ridiculous. Attached are pictures for the day after the snowfall in December 2020. As you can clearly see, there was no snow removal done by 9:00 am. When maintenance finally came at 10:00 am they were plowing the snow in the parking lot and blocking cars in. Moving forward to the snowstorm in February, which was more than the one in December, and the lack of common sense from management and the employees is beyond me. Why is building 220 always neglected? It is never cleaned unless the tenants complains. I was told the employees were out. How come no one was hired on a temporary basis? I am also still waiting for repairs to be done from my move-in.
- Chairman Rodriguez: Ms. Grullon, I know this is not the first time she has addressed the Board and it seems to be an ongoing problem. Leidy, if you can give us some insight on what's going on and what are we planning to do with Ms. Grullon.
- Ms. Brito: A few days after the last Board Meeting I spoke with Ms. Grullon over the phone. She expressed how there were some Covid scares in her family and she said she doesn't want anyone in her house right now and she will reach out when she feels comfortable having people in her house. I have not heard from Ms. Grullon since.
- Chairman Rodriguez: If you can, would you give her a call back, possibly tomorrow, to get that straightened out and report back to us at the next meeting. Ms. Grullon also touched on the snow removal process. I know there were some issues. I just want to make sure that we are okay because there is another snowstorm coming. I want to make sure that we're prepared and the issues we had in the past will not be occurring again.
- Ms. Brito: We are fully prepared and ready for tomorrow's snowstorm.

- Commissioner Juszcyk: I separated this resolution for one of the usual reasons, so that any commissioners with a relationship with the Passaic Valley Water Commission could abstain on payment to said agency. Also, I'd like to comment about the payment to PVWC. It's almost \$34,000. Unfortunately, the commissioners of the PVWC have chosen to increase the rates by 3% again. They have been raising it every January. When I spoke to a former commissioner of the PVWC he informed me that this would be done all the time because people were conserving water. So in order to make up for the deficit of water use, they would have to raise the rates. I think that's a feeble reason and unfortunately, PVWC is a monopoly and we can't get our water anywhere else. I'm just venting frustration with that as a Commissioner and as a private citizen.

2021-09 RESOLUTION AUTHORIZING AN AWARD OF CONTRACT TO ERIC M. BERNSTEIN & ASSOCIATES FOR ORDINARY LEGAL SERVICES FOR A PERIOD OF TWO (2) YEARS AT AN ANNUAL RATE FOR THE FIRST YEAR NOT TO EXCEED FORTY-SIX THOUSAND EIGHT HUNDRED DOLLARS (\$46,800.00) AND FOR THE SECOND YEAR NOT TO EXCEED FORTY-EIGHT THOUSAND DOLLARS (\$48,000.00) AND AN HOURLY RATE OF ONE HUNDRED TWENTY DOLLARS (\$120.00) PER HOUR

- Commissioner Juszcyk: I am going to address this to the Chairperson, since your name is on the bottom of the Resolution. This contract was awarded to the firm with the lowest evaluation score and the highest monetary bid. What was the criteria that was used to award this contract? - Chairman Rodriguez: That was done by Executive Director Mitchell. She would be able to answer that for us. Director Mitchell, we can't hear you. I'll attempt to answer your question.

Basically, from what we discussed, they did the grading system on it. It felt it was important that there were a lot of open items that Mr. Bernstein was taking care of, as well as the great job that he's been doing over the year with us and the constant communication that he's had with us. So it felt that it would be in the best interest of the agency to bring back Mr. Bernstein.

- Commissioner Juszcyk: Is it not correct that all of our attorneys always have open cases that they're looking into? We did in the past terminate Breslin & Breslin even though they had many open cases.
- Chairman Rodriguez: That is correct. Again, one of the reasons is the value Mr. Bernstein has brought to us with the cases he is currently dealing with. I don't know how smart or if we have the wisdom at this time to make a switch during the pandemic to a different attorney.
- Commissioner Navarro: When bidding out, there's a per year contract and then the hourly rate. What's the bottom line number and how do we get invoiced for services?
- Mr. Bernstein: You get billed a monthly fee and you only get billed the hourly rate if it's an extraordinary service, which requires Board approval in order to authorize same.
