REMARKS BY CITIZENS

The following was read: In accordance with the Open Public Meetings Act (N.J.S.A. 10:4-1 et seq.) The Housing Authority of the City of Passaic opens every public meeting for comments from the public. Each person choosing to speak at the meetings will be limited to five minutes, to speak on any subject, on or off the agenda. All speakers must state their name and address for the record. However, in accordance with N.J.S.A. 10:4-12 "nothing in this Act shall be construed to limit the discretion of a public body to permit, prohibit or regulate the active participation at any meeting"

Therefore, please be advised that the Housing Authority of the City of Passaic will not entertain any comments from persons who communicate obscene material, make statements which are considered bias intimidation in which a person intends to intimidate any individual or group because of race, color, religion, gender, handicap, sexual orientation or ethnicity or makes comments intending to harass or speak in any offensive language. The person who makes these statements will relinquish their allotted five minutes for public discussion. Any person who persists in speaking out of turn, or interrupts the peace and order of the meeting will be escorted off the premises.

Due to Covid19, members of the public who had questions or comments were asked to submit them in writing to the administrative office located at 52 Aspen Place or send them via email to the Executive Director at <u>boardmeeting@passaichousing.org</u> before the close of business day at 4:00 pm Tuesday, December 15, 2020.

Director Mitchell: We have three citizen comments. I would like to enlighten you on a chat that came in last month just to put the response on record because there wasn't an email attached. On zoom last month, it was asked if we can have clarification on which appropriations are for recreational programs for the children. My brief response was: the appropriation are not for recreational activities for the children. HUD doesn't provide funds for recreational activities. It is not an allowable expense. But Residents Service budget is to provide children with resources and educational activities to assist them in becoming self-sufficient.

1.) May Francis Ray – 226 Chestnut St: Commented on having competent people to answer questions, please answer the phones, and flat rent concerns. It was her

understanding that the flat rent option was for every three years and the concern was that particular size unit went up over \$100 this year.

- 2.) Rene Griggs 23 Aspen Pl. Apt. 6C: I am very disappointed in the last two years in the leadership of Chestnut Gardens and especially of Vreeland Village Tenant Association. Anything I am referencing can be backed up by the director of finance. Both developments have not been supportive in no kind of way to Speer Village. Speer Village has paid for tickets, has underwritten programs with financial support for events such as Black History, the Halloween Safety Program, Christmas events, etc. for both sites. It has also paid to send leadership of those associations to conferences/seminars. Neither President has made a donation to the cause. You need to know not even one bag of candy was brought to the kids to the event Speer had.
- 3.) Angelica Grullon 220 Sixth St. Apt. 3D: Last month I sent an email regarding unresolved issues since I had moved in. They are still unresolved. I do not think it is my responsibility to follow up with maintenance on the work orders that were issued to my unit. When the maintenance repairman came to my unit to resolve the window issue, he said I should go to the dollar store and purchase the weather strip for the windows so the air does not seep through them. I called on Monday, the 21st of November, in the morning regarding not having hot water. When I called in the afternoon to follow up, I was informed by the receptionist, Clarissa, that they were working on the issue. I received a notice late that day that they were working on the issue. I called the office the next day to ask for an estimate of when the issue would be resolved and her assistant (can't remember her name) couldn't give me an estimated time frame because she didn't know about it. Finally, on the 23rd I saw the company that was fixing the problem and I asked what was the issue. He literally said it was due to poor maintenance on the equipment. I suggested to the current manager, Leidy, that they should procure new hot water heaters and she said they are less than two years old. Why, if they are practically new, have I been without hot water 4 times in the 3 months I have been living here? Are they not maintaining the hot water heaters? I would also like to know why our building wasn't cleaned the whole month of November? I saw the maintenance guys around, but never inside cleaning the buildings. I also put in a work order because the face of the cabinet came off and it is still off. I understand it's not an emergency, but how long are they taking to complete work orders?

- Chairman Rodriguez: I know Ms. Grullon reached out to us last month regarding issues. What was going on with that the she felt she had to reach back out today? I know we were having problems with hot water at Vreeland but I thought those were fixed.

- *Ms. Brito: We were having problems with 201, 203, 220 and 222 Sixth St not having hot water. The problem was the mixing valves were damaged. I reached out to the company that replaced them back in March and they were replace again. So the problem with the hot water was resolved.*

- Chairman Rodriguez: When you say damaged, do you mean the valve broke or someone went in there and did something to it?

- *Ms. Brito: The valves were actually corroded. They were still under warranty so they came in and replaced them at no cost.*

- Chairman Rodriguez: Going forward, is that something that can happen? Are we gonna have to worry about it 6 months or a year from now?

- *Ms. Brito: We haven't encountered a problem with the mixing valves in the other buildings, it just happened to be those two specific buildings.*

- Chairman Rodriguez: Leidy, if you can follow up with Ms. Grullon regarding her concerns and give her a timetable of when certain things will get fixed. Give her an explanation if there are certain things we do or don't provide.

- Commissioner Johnson: When sites have events, can Commissioners get notice a week or two in advance so if they need donations we can give donations. There have been a lot of complaints about maintenance not cleaning the buildings.

- Chairman Rodriguez: If issues happen, like hot water being off, we should pass the information around so the person answering the phone should be informed. If there is a calendar of events, it should be sent out monthly.
