REMARKS BY CITIZENS

The following was read: In accordance with the Open Public Meetings Act (N.J.S.A. 10:4-1 et seq.) The Housing Authority of the City of Passaic opens every public meeting for comments from the public. Each person choosing to speak at the meetings will be limited to five minutes, to speak on any subject, on or off the agenda. All speakers must state their name and address for the record. However, in accordance with N.J.S.A. 10:4-12 "nothing in this Act shall be construed to limit the discretion of a public body to permit, prohibit or regulate the active participation at any meeting"

Therefore, please be advised that the Housing Authority of the City of Passaic will not entertain any comments from persons who communicate obscene material, make statements which are considered bias intimidation in which a person intends to intimidate any individual or group because of race, color, religion, gender, handicap, sexual orientation or ethnicity or makes comments intending to harass or speak in any offensive language. The person who makes these statements will relinquish their allotted five minutes for public discussion. Any person who persists in speaking out of turn, or interrupts the peace and order of the meeting will be escorted off the premises.

Evelyn T. Robinson – 222 Sixth St. Apt. 2D: I'd like an explanation on Resolution 2023-04 - shared services with the agreement of the City and 2023-07 with regard to hiring a firm for temporary employment. And turning to my report, if you can look, this is the problem we're having at Vreeland with dogs. There was a little boy holding onto a dog and it lunged at me and I had to run in the other direction. He's not the only one, there are other pitbulls and dogs larger than pitbulls. Something has to be done; the pet policy has to be adhered to. One thing that came up that we're concerned about is the building on Wall Street is almost complete. What we're concerned about is parking. We're being bombarded in the most crowded part of the City of Passaic with buildings. There's a need for them, but something has to be done about the parking. I'm sure Mr. Smoot can tell you how many calls he gets regarding no parking. There are 82 parking spaces and 116 apartments. Some people have more than 1 car. When we had our family and friends event we had to have a van towed that was sitting in the lot for 3 months with Massachusetts plates on it.

- Chairman Rodriguez: Resolution 2023-04 is going before the Board today for approval. It is a shared services agreement. As many of you may or may not know,

Ms. Pamela Mitchell is entering her time of retirement as of December 31, 2022. She is not officially retired, but she is no longer here to run the day-to-day operations. We needed an interim Executive Director, so we're going to hopefully pass this resolution for a shared services agreement with the City where they will provide us someone with interim while complete the process of finalizing Ms. Mitchell's retirement and we can go out to find a new Executive Director. The interim is Mr. Ron Van Rensalier, who has experience with Housing. As for as 2023-07, Mr. Bernstein?

- Mr. Bernstein: The request was made by administration to go out and seek the possibility of a temporary employment firm. No one has been hired yet. They're looking to solicit, subject to Board approval.
- Ms. Robinson: What was the rationale for that?
- Haydee Capellan: We currently have had a firm. It was Human Edge. Their agreement was for one year. There are projects within the agency that doesn't require a full time position. In section 8 there are 2 vacancies. They will help out with filing and interviews. It's a temporary matter so they will help us out.
- Chairman Rodriguez: I am aware of the parking issue. It is something we are working on with Mr. Smoot and the police department. I am also aware of the dog issue. What we're doing, from my understanding, is work with the City to find out what licenses were given to who, reconcile with our files, and Mr. Smoot is going assist in finding out who's supposed to have a dog and who's not supposed to. We're also looking at the policy to make it more direct.
- Commissioner Navarro: I thought the policy was specific to what size the dog can be.
- Chairman Rodriguez: I want to take a look at the policy directly. It's from a couple of years ago. There's also a fee; about \$150, which I can see may deter someone from registering their dog. So we're looking to reconcile everything with Mr. Smoot. We also need to make sure it's across the board.
